In response to the request for a breakdown of our 2010 declared/paid dividends between income, capital gains and return of capital on our Common Stock, the following represents the allocation that supports your Form 1099.

The total amount of cash distributions to be reported on the 2010 Form 1099 is \$0.40 per share of which \$0.40 per share is taxable as ordinary dividend income and none is taxable as long-term capital gains.
