In response to the request for a breakdown of our 2010 declared/paid dividends between income, capital gains and return of capital on our Series C Preferred Stock, the following represents the allocation that supports your Form 1099.

The total amount of cash distributions to be reported on the 2010 Form 1099 is \$1.9064 per share of which \$1.9064 per share is taxable as ordinary dividend income and none is taxable as long-term capital gains.
